

ABOUT NBME COMMITTEES & TASK FORCES

We are grateful and proud to list the names of the medical educators, academic researchers, health care leaders, and other professionals who served as committee or task force members in 2023. These individuals' diverse backgrounds and experiences, which are fortified by continuous learning and professional development, support collaborative relationships with NBME. In doing so, NBME can create and deliver high-quality, reliable assessments that measure medical students' and health care providers' clinical readiness and aptitude.

In 2023, 283 individuals contributed to an NBME committee or task force. Of these, 52% identified as women and 39% as men¹. More than 36% identify as from a historically underrepresented racial and ethnic group².



More than 61% of members held a medical degree; nearly 29% held both a medical degree and an additional advanced degree; more than 5% held a PhD alone; and nearly 5% of these members held other degrees from various disciplines. Geographically,

- nearly 34% of committee members were from the Southern United States;
- more than 18% were from the Central United States:
- nearly 28% were from the Northeast; and
- nearly 15% were from the West Coast.

Additionally, more than 5% of committee members came from outside the United States. More than 19% of members speak one or more languages other than English.

More than 6% of committee members reported to be either current or former members of state licensing boards.

Altogether, individuals from more than 161 organizations served on an NBME committee or task force.

IFOM BASIC SCIENCE TASK FORCE

IFOM Basic Science Task Force members are responsible for reviewing items for the IFOM Basic Science Examination (BSE) forms to ensure that individual items are accurate and current, and that the finalized exam forms are balanced in terms of content breadth and depth. They also provide comments as to whether certain content areas need further discussion and review in light of changing trends in medicine in their area of the world. Reviewing test forms for this international examination requires current medical expertise and knowledge of actual medical practices and medical school curricula across their region of practice. It also requires flexibility and openmindedness and the ability to work with a diverse team of faculty representing various specialties and every region of the world.
